Pursuant to the invitation for expression of interest dated 12th July 2022, issued by the Resolution Professional under the provisions of Section 25(2)(h) of the Insolvency and Bankruptcy Code, 2016 ("**Code**") read with Regulation 36A of the IBBI (Insolvency Resolution Process for Corporate Persons) Regulations, 2016 ("**CIRP Regulations**") for the corporate insolvency resolution process of SKS Power Generation (Chhattisgarh) Limited("**Corporate Debtor**") the Resolution Professional had received expression of interest from the various entities to submit the resolution plans as prospective resolution applicant ("**PRAs**"). The provisional list of PRAs was published by the Resolution Professional ("**RP**") on 07<sup>th</sup> August 2022. As per sub-regulation 11 of Regulation 36A of the CIRP Regulations, any objection to inclusion or exclusion of a PRA in the provisional list may be made with supporting documents within 5 (five) days from the date of issue of the provisional list.

Since, the RP has not received any objections as mentioned in sub-regulation 11 of Regulation 36A, hence, in accordance with the provisions of sub-regulation 12 of Regulation 36A of the CIRP Regulations, the RP issuing the final list of eligible PRAs to the CoC.
